Ann Louise Schreiner, age 77, of Kimbolton, OH. Passed away Tuesday, September 10, 2019 at her home. She was born on February 1, 1942 in Chicago to the late G. Wayne Rogers and Delores Hoffman Rogers.

Ann worked as a Registered Nurse at the Cleveland Clinic and retired from Medical Mutual of Ohio as a senior contract negotiator. She and her husband moved to Guernsey County full time in 1998. Mrs. Schreiner was named by the Guernsey County Senior Citizens Center as the "Guernsey County Angel of Seniors" in 2012. She served on the Area Agency on Aging Region 9 board of directors and as president of the advisory board. She also served on the board of the Guernsey County Cancer Society, the board of directors of Guernsey County Feed My People, a member and board member of Christ's Lutheran Church, and on the board of Thrivent for Lutherans, in which she spent two terms as president.
