Annajeane Law, age 87 of Cambridge, died on Friday, January 17, 2014 at the Beckett House in New Concord with her children at her side. She was born in Cambridge on November 10, 1926, a daughter of the late John Maslowski and Sophia (Havlicek) Maslowski.

Mrs. Law was a 1944 graduate of Cambridge High School. In her early career she worked at the U.S. Pentagon in Washington D.C.; Fletcher Hospital in Cambridge; and the Cambridge Pottery. Annajeane was the third person hired at the newly opened Guernsey Memorial Hospital in 1952 where, she was the secretary to the first Administrator.

Later, together with her husband, Milton O. Law they owned and operated Bundy-Law Funeral Home.

She was a member of the First United Methodist Church, Business and Professional Girls, Eastern Star Chapter 211, and her Ocho card club. She volunteered for several charitable organizations including The Salvation Army and March of Dimes.

She enjoyed her granddaughters, flower gardening and was a wonderful homemaker.
