Charles R. Lake of Cambridge died August 7, 2012. He was born January 11, 1925 in Cambridge, the son of Fred and Freda (Williams) Lake. He was a graduate of Cambridge High School. He served in the US Army in World War II where he received a Purple Heart for injuries he received as a member of a mine-sweeping unit.

Following the War he returned to Cambridge where he married Mary "Joan" Siegfried. He and his wife Joan owned and operated Center Food Locker/Lakes Market on Rt. 22 in Center until 1968 when they moved the family to Florida. There he owned and operated several businesses, worked as a butcher, owned rental properties, and delivered fuel oil until his retirement. He and Joan spent many summers in Cambridge and returned full time after retirement. He was a life long member of Center United Methodist Church where he was very active. He was a member of the American Legion, Purple Hearts, VFW, Elks, DAV and Eagles. He regularly attended Golden Sixties and was last a resident of Maple Heights.

He was preceded in death by his wife of 58 years Joan Lake, who passed away in 2004, a daughter Cathy, his parents Fred and Freda Lake and a his sister, Marie Lake Siegfried.

He is survived by two son's Dave (Kathy) Lake and Jim Lake, all of Ft. Myers, Florida, a daughter Judy (Greg) McCoy of Columbiana, Ohio, a grandson Shawn McCoy currently of Des Moines, Iowa, and two nieces Bess Siegfried and Sue (Allan) Strawsburg of Cambridge. He is also survived by his very

dear friend Martha Mount of Cambridge.
