



Edith M. Reardon

September 30, 1915 - November 27, 2003

Edith M. Reardon, a long-time resident of Cambridge, died this past Thursday at The Cardinal House. She was born Edith Carmitchel on September 30, 1915, in Mt. Carmel, PA, where she grew up, worked and was married on November 18, 1939. Her husband, Joseph C., who died in 1986, was a Federal Coal Mine Inspector, based in Cambridge, until his retirement. They moved to Cambridge with their young Family on Labor Day weekend 1946, in the aftermath of World War II, when housing, appliances, and automobiles were in short supply.

Until retiring to the Cardinal House in Fairdale in 1998, Mrs. Reardon resided at 626 North Eight Street, where she raised her family. She is survived by her five children: Joseph P. wife Janelle of Fairview Park, Ohio; Francis Andrew Trudy of Westerville, Ohio; Mary Ann McGarry of Annapolis, MD; James D. Dolores of Hummelstown, PA; and Robert J. Candy of Cambridge, Ohio. There are ten grandchildren and 7 great grandchildren, as well as a surviving brother, Robert Carmitchel of Lancaster, PA, and cousin, James Jones of Mt. Carmel, PA

Mrs. Reardon was first and foremost a devoted mother and homemaker. She was an active member of St. Benedict's Catholic Church and the Catholic Daughters of America.

Funeral service is at 10:00 A.M. Monday, December 1, 2003 at St. Benedict's Catholic Church, with Father Robert Borer officiating. Burial will be in Mount Calvary Cemetery.
