Harriette Moore Gaskill, age 90 formerly of Cambridge, passed away on Tuesday, August 18, 2015 at First Community Village in Columbus, Ohio. She was born on November 6, 1924 in Quaker City, Ohio, a daughter of the late William J. Moore and Lottie Spencer Moore.

Mrs. Gaskill graduated from Quaker City High School and attended the Elliot School of Business.

She was a long time employee for the Cambridge City Schools where she served as secretary to the principal at Cambridge Junior High School and as secretary to the Superintendent of Schools from which she retired in 1982. She especially enjoyed the young men and women who assisted her at the junior high and working for Dr. James A. Clark in his tenure as superintendent.
