



## Jack M. Roudebush

May 24, 1933 - July 22, 2015

Jack M. Roudebush, age 82 of Cambridge, passed away on Wednesday, July 22, 2015 at Cambridge Health Care Center. He was born on May 24, 1933 in Steubenville, a son of the late Sheve Roudebush and Margaret (Orndoff) Roudebush.

Mr. Roudebush served his country in the U. S. Air Force during the Korean War and also served in the Navy Reserves. He was a member of the First Baptist Church in Cambridge.
