



## Janet M. Brown

September 23, 1929 - March 15, 2016

Janet M. Brown, age 86 of Cambridge, Ohio, passed away Tuesday, March 15, 2016 at Riverside Methodist Hospital. She was born September 23, 1929, to the late George Dewey Heldman and Julia A. (Worstell) Heldman, in New Matamoras, Ohio. She was a 1947 graduate of Cambridge High School. Along with her parents, Janet was preceded in death by her brother Donald G. Heldman and sister -in-law Delores E. Heldman Walters, and her husband Dean V. Brown who passed away May 19, 2008. Dean and Janet were married on September 26, 1947.

Janet is survived by one son, Attorney Donald D. (Terry Dankovic) Brown of Cambridge, Ohio, and two daughters, Kathy E. (Rich) Hobbs of Dublin, Ohio, and Amy L. (Dave) Yanka of Lewis Center, Ohio. Presbyterian by faith, Janet served for many years with her husband Dean as Church Host and Hostess for the Second Presbyterian Church until its merger with Unity Presbyterian Church. She was an adviser for the church youth fellowship and was always actively involved in school support organizations for each of her children.

In addition to being a great full-time mother and homemaker, Janet worked for

and retired from GTE. She was also employed over the years at Cambridge Savings Bank and served as director of the guernsey County Food Stamp Distribution Center. Along with her husband, she was an owner-operator of the former Fairdale Motor Lodge.

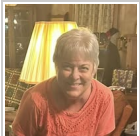

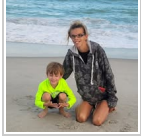
