John R. Sneddon, age 86 of Cambridge, passed away on Monday, February 20, 2017 at Ohio State University Medical Center. He was born on October 13, 1930 in Cambridge, a son of the late Robert B. Sneddon and Emma L. (Hammond) Sneddon.
