



## Martha Delik

September 11, 1928 - February 24, 2018

Martha Delik, age 89 of Pleasant City, passed away on Saturday, February 24, 2018 at her home. She was born in Walhounding, Ohio on September 11, 1928, a daughter of the late John Pipa and Ann (Branchik) Pipa.

Mrs. Delik was a 1946 graduate of Senecaville High School. She was a member of Christ Our Light Parish in Cambridge. Martha retired from the Guernsey County Health Department in 1987 after 25 years of service. She was in charge of birth and death certificates and the WIC program. She met with our own John Glenn to give him his birth certificate. Martha baked nut rolls, pies, cakes and bread among other things and attended farm markets and festivals. She enjoyed working in her garden, the occasional trip to Wheeling Island with her sister Clara and spending time with her family and friends.

Martha was preceded in death on May 3, 2015 by her husband Paul Thomas Delik, they were married on June 30, 1951. Also deceased are two brothers, John and Mike Pipa and a sister Ethel Hunady.
