Martha A. Salmans Ross, age 87, of Cambridge, OH passed away Friday September 29, 2017 at The Southeastern Ohio Regional Medical Center. She was born September 18, 1930 to the late Frank R. Larimer and Lorena M. Kistler Larimer in Logan, OH.
