Richard L. Atchison, age 86 of Pinehurst, North Carolina, formerly of New Concord, Ohio died on Saturday, December 27, 2008 at Manor Care in Pinehurst, North Carolina. He was born on May 22, 1922 in Bloomfield, Ohio, a son of the late Ralph and Mary Rankin Atchison.

He attended New Concord High School, graduating in 1940. After graduating Muskingum College in 1942, Mr. Atchison then entered the US Air Force and became a commissioned officer. In 1951 during the Korean Conflict, he served as a fighter pilot flying over 150 combat missions. He holds the Distinguished Flying Cross and the Air Medal earned from his service. Richard retired from military service in 1963. He then worked as a civil service employee for the US Air Force division at the Pentagon. After retirement, he remained active with various volunteer jobs.

Mr. Atchison was a member of the Bloomfield United Presbyterian Church in New Concord, Ohio and the Culdee Presbyterian Church in West End, North Carolina.

Preceding him in death are his parents, a daughter, Bonnie Beth who died in infancy and a brother Robert Atchison.
