



## Wayne O. Mehaffey

March 5, 1925 - April 26, 2013

Wayne O. Mehaffey 88, of Cambridge, died peacefully Friday, April 26, 2013 at Southeastern Ohio Regional Medical Center.

He was born March 5, 1925 in Guernsey County, son of the late William B. and Edna Margaret (Oliver) Mehaffey. Wayne was a graduate of New Concord High School. He retired from Champion Spark Plug after working 33 years. He was a life long member of First Presbyterian Church where he served as an Elder and Trustee.
